Mobility in Soil: Volatilization to air is not expected to be a significant fate process due to the low vapor pressure of this material. In water, this material does not impart any sheen and will float and spread over the surface at a rate dependent upon viscosity. The main fate process is expected to be slow biodegradation of individual components in soil and sediment. Volatilization to air is not expected to be a significant fate process due to the low vapor pressure of this material.
